REGISTRATION

Registration forms must accompany your scarecrow and all scarecrows must be set up in the pumpkin patch by October 22nd.

SCARECROW RULES

Be Creative! You will have an 8 foot x 5 foot space within the Scarecrow Gallery to display your creation (no limit on the number of scarecrows or props used, however they must fit within the space provided). There is no power available for displays and power generators are prohibited.

We will provide you with a metal post to attach your scarecrow to (you are responsible for the attachment process). Additional posts can be provided upon request.

The Scarecrow Gallery is an outdoor gallery, therefore your display will be subject to the elements (i.e. wind and rain). Please make sure that all items are securely fastened to your display.

No offensive material may be displayed.

SCARECROW DROP OFF/PICK UP

Scarecrows may be set up at the Suisun Valley Pumpkin Patch (located at 4443 Suisun Valley Road, Suisun Valley, CA) between the hours of 10am-6pm September 25th – October 22nd.

Entries received by October 2nd will receive 2 FREE passes to the pumpkin patch (5 for Business entrants). Scarecrows must be received at the Suisun Valley Pumpkin Patch no later than 6:00pm, October 22nd.

Scarecrows must remain in the Scarecrow Gallery through Sunday, October 31st. Scarecrows must be picked up between 10am – 2pm November 1st – 3rd. You are responsible for removing all items out of your gallery space within that time frame. All items left on the premise after November 3rd will be discarded.
